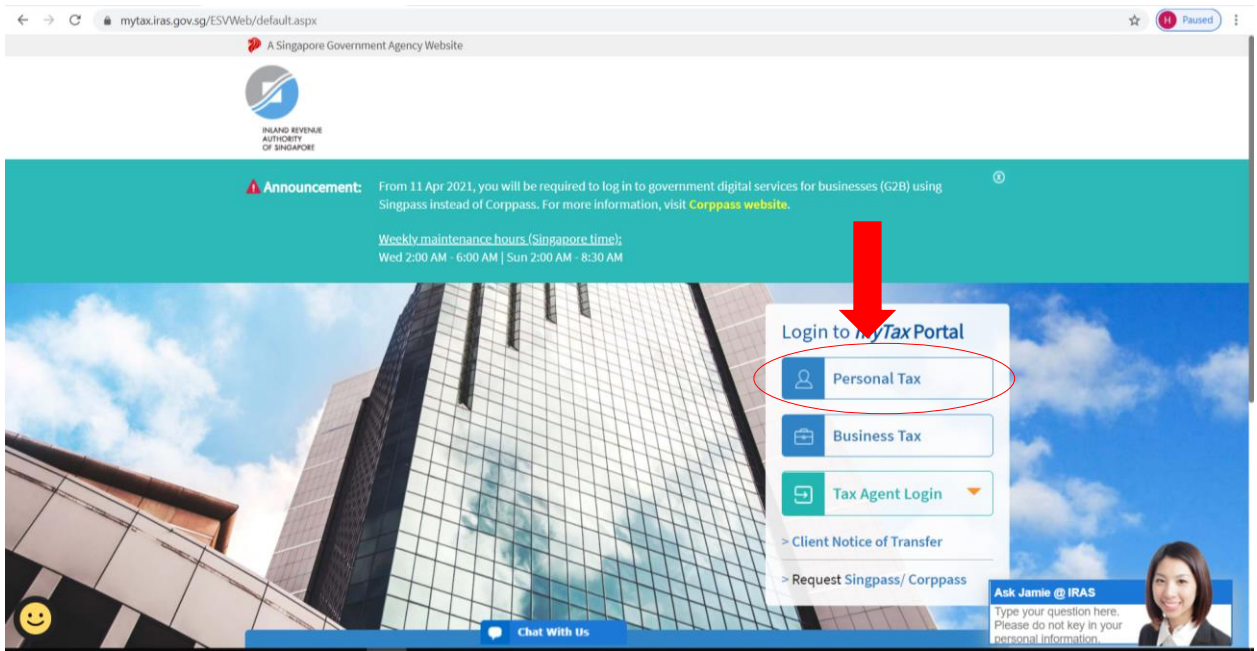
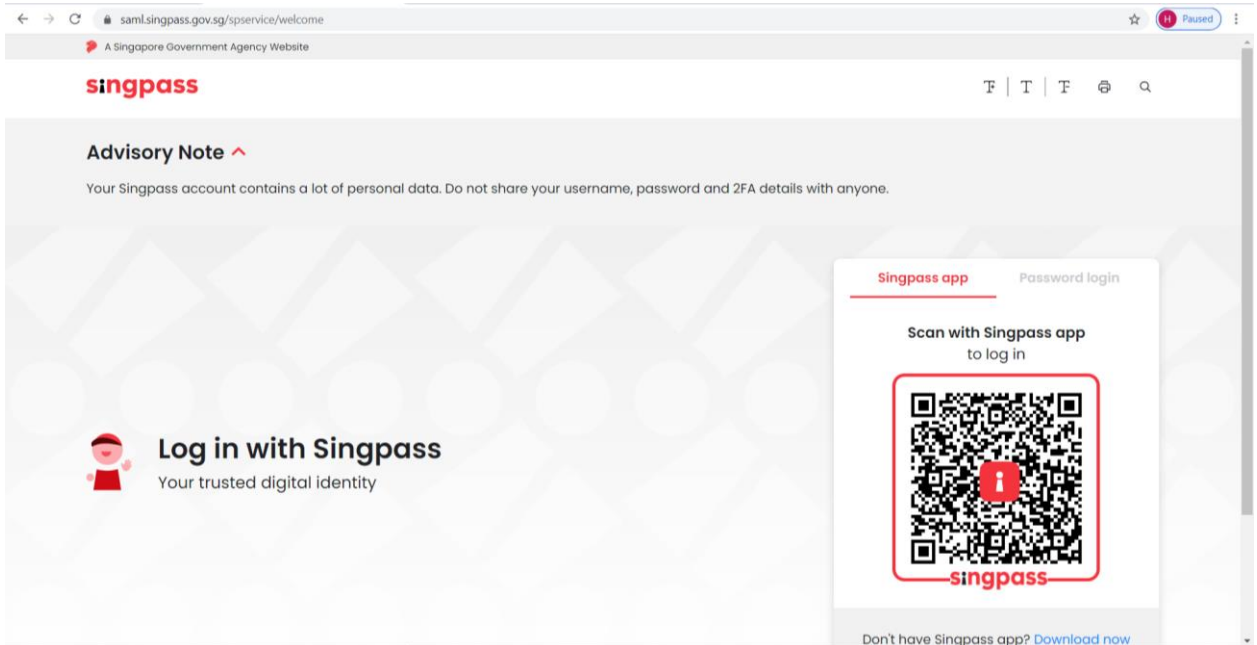

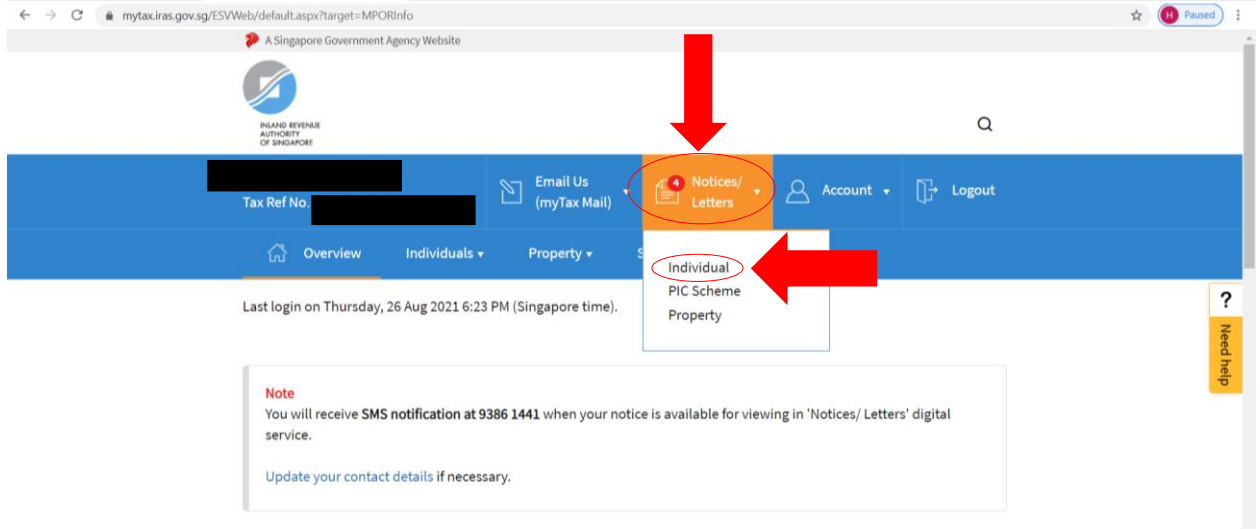
- 1) Go to IRAS website (mytax.iras.gov.sg). Select 'Personal Tax'.



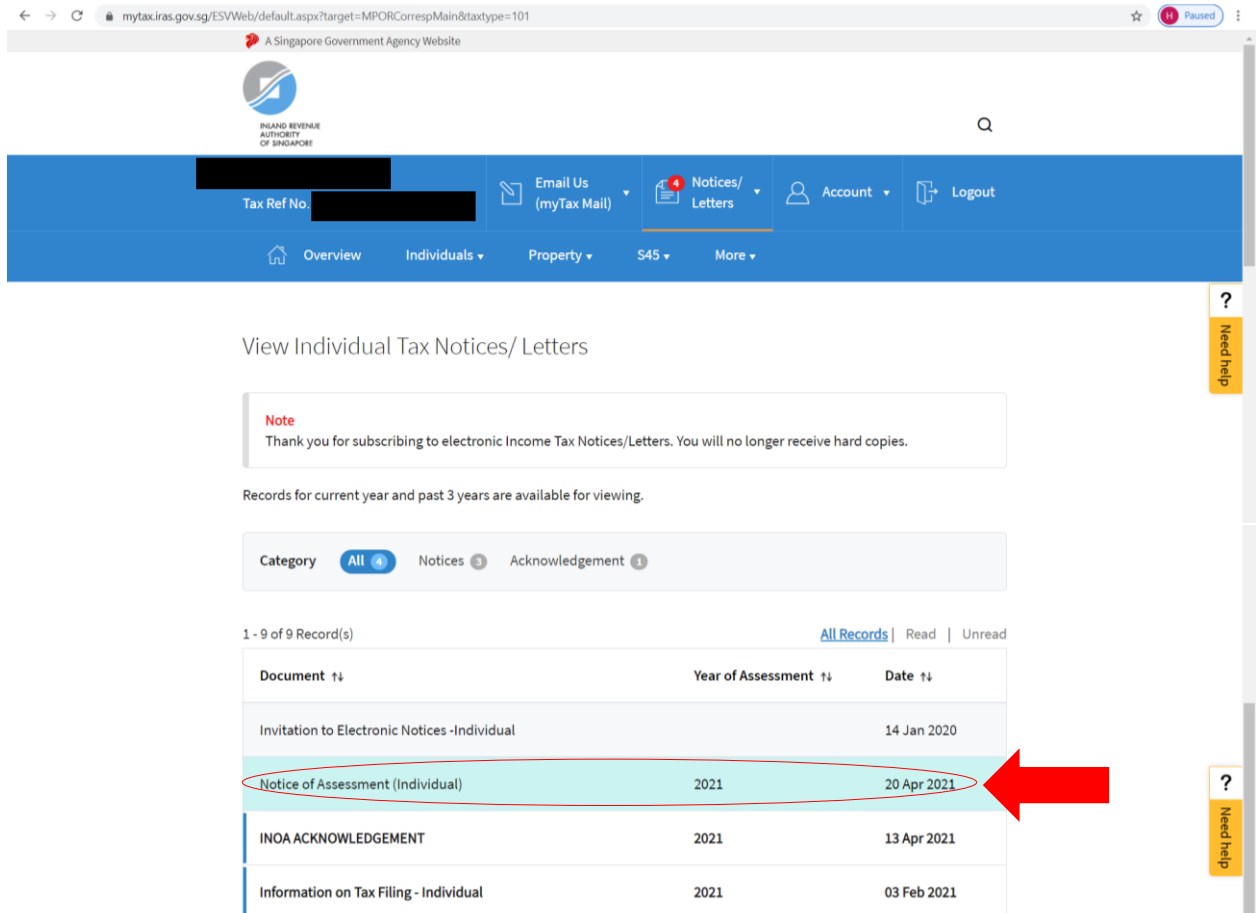
- 2) You will be brought to login page. Log in with Singpass.



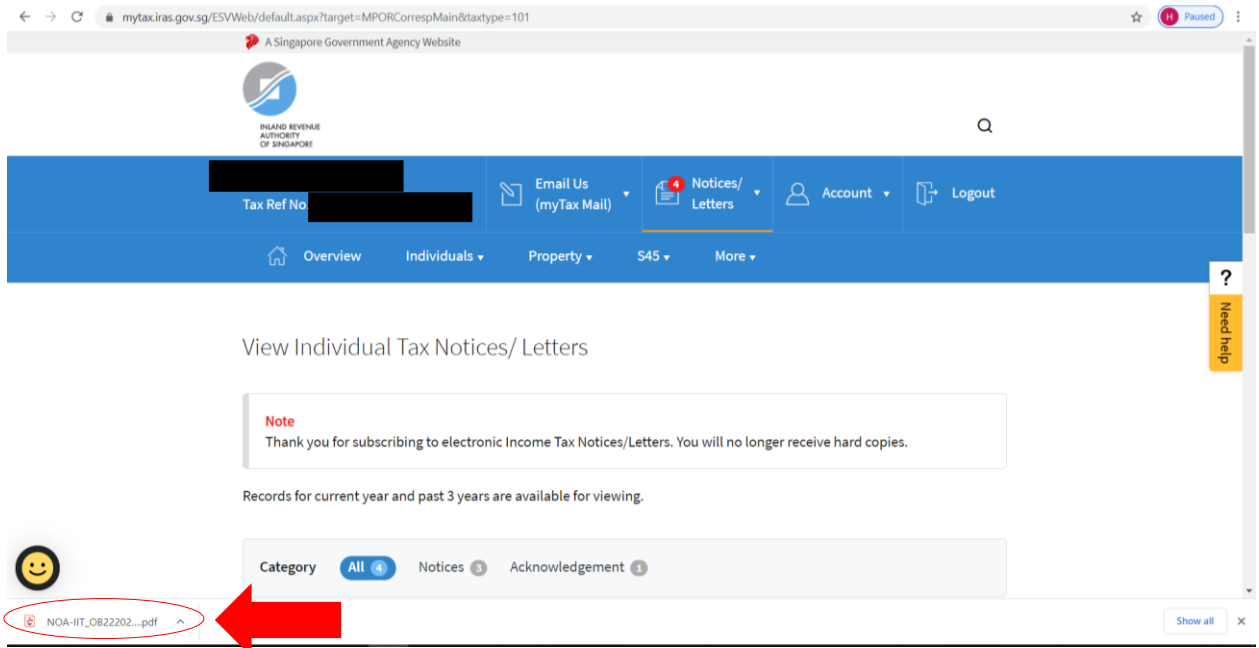
3) Click on 'Notices/Letters' and select 'Individual'.



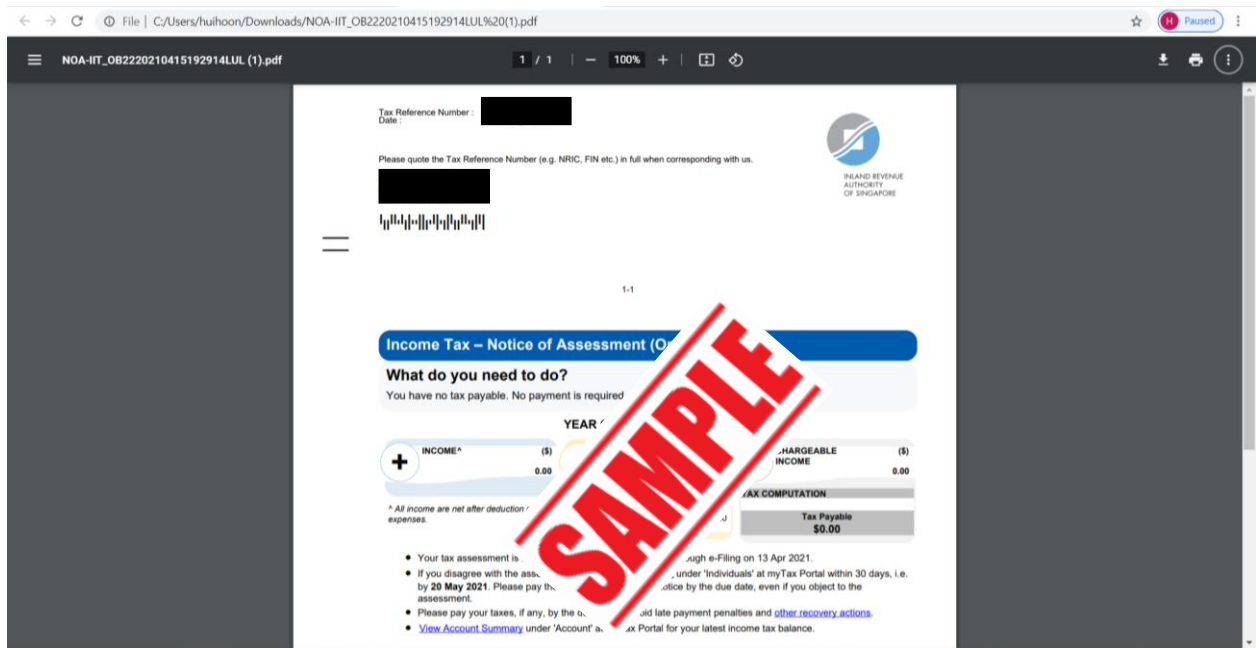
4) Select the Notice of Assessment (Individual) for the Year of Assessment that you want

6) Download and submit the document to us.

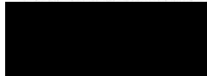

- Self-employed income (e.g. hawker, commission agent) with an annual net business income that exceeds \$6,000; or
- Gross rental income (before deducting rental expenses) that exceeds \$22,000; or
- Other sources of income (e.g. withdrawals from Supplementary Retirement Scheme) that exceeds \$22,000.

More than one source of income

- Total income exceeds \$22,000 (e.g. employment and gross rental income); or
- Annual net business income exceeds \$6,000 (e.g. hawker, commission agent).


**What do you need to do?**

To file a tax return,

- Log in to [mytax.iras.gov.sg](https://mytax.iras.gov.sg) using your Singpass from **1 Mar to 18 Apr** of each year.
- Select "Individuals" > "Filing Matters" and "[File Income Tax Return](#)".

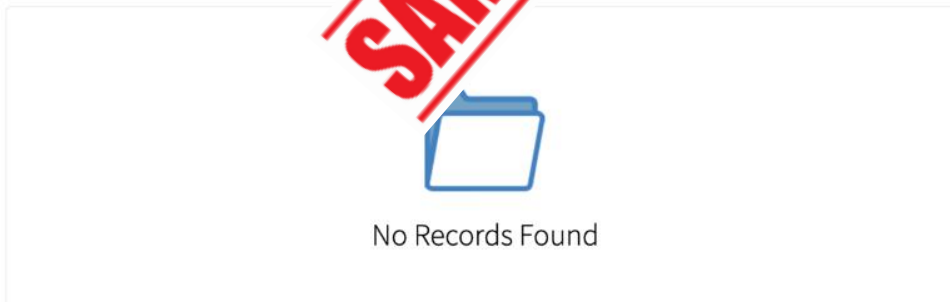
